- WHEREAS, Pennsylvania Act 118 of 2020 was enacted on November 25, 2020 to provide financial relief to charitable clubs and service organizations with Small Games of Chance licenses, by allowing them to use 100% of proceeds from Small Games of Chance for internal operational expenses, rather than the standard 40%, during the COVID-19 Emergency Declaration and a period of 365 days after the termination of the Emergency Declaration; and WHEREAS, These organizations are the backbone of our communities, providing a place for our Veterans to congregate, supporting many local charities, and funding many local community projects; and WHEREAS. The citizens of the Commonwealth of Pennsylvania voted to give the ability to end the Emergency Declaration back to the General Assembly on May 18, 2021; and WHEREAS, The General Assembly of the Commonwealth of Pennsylvania voted on June 10, 2021 to end the COVID-19 Emergency Declaration; and WHEREAS, The COVID-19 Emergency Declaration formally ended on June 15, 2021 with the certification of the results of the May 2021 elections; and The time period for these organizations to use 100% of Small Games proceeds WHEREAS. will end in June 2022, but the reporting period extends until December 31, 2022, aligned with the calendar year; and Many of these organizations still have not fully recovered from the impact of the WHEREAS. pandemic, and still struggle to make ends meet; and WHEREAS, The interim between the use of, and the reporting of, these funds will likely cause undue confusion, errors and unintended infractions in reporting, and additional stress to the primarily volunteer administrators of these organizations and to the personnel receiving and filing the reports within the Department of Revenue; and WHEREAS, The errors and inadvertent infractions caused by the confusion in the interim
- WHEREAS, Extending the deadline to use 100% of Small Games of Chance proceeds to match the reporting period will give these vital service organizations more time to recover and keep their doors open to remain an integral part of our communities,

- WHEREAS, In view of the foregoing, we, the membership of The American Legion Department of Pennsylvania, respectfully petition the General Assembly of the Commonwealth of Pennsylvania to develop and pass legislation to extend the deadline for the provisions of Act 118 of 2020 to December 31, 2022, and the Governor of Pennsylvania to enact said legislation; now, therefore, be it
- RESOLVED, That the Department Executive Committee of The American Legion Department of Pennsylvania in regular meeting assembled at the Comfort Inn RIDC Park, Pittsburgh, PA, April 29 to May 1, 2022, affirms support from The American Legion Department of Pennsylvania for legislation that extends the deadline of Act 118 of 2020 allowing charitable clubs and service organizations to use 100% of Small Games of Chance proceeds to cover general operating expenses during the COVID-19 Emergency Declaration to December 31, 2022 in order to give these vital service organizations more time to recover and keep their doors open to remain an integral part of our communities; and be it further
- RESOLVED, That The American Legion Department of Pennsylvania urges the Legislature of the Commonwealth of Pennsylvania to then expeditiously pass such legislation and present it to the Governor for signature; and be it further
- RESOLVED, That The American Legion Department of Pennsylvania urges the Governor of Pennsylvania to then expediently enact this legislation by signature; and be it further
- RESOLVED, That a copy of this Resolution be forwarded to all members of both chambers of the Pennsylvania General Assembly, and the leadership of the member organizations of the Pennsylvania State Veterans Commission and the Pennsylvania War Veterans Council; and be it finally
- RESOLVED, That a copy of this Resolution be forwarded to Pennsylvania Governor Thomas Westerman Wolf.
