The following registration plate may **ONLY** be used on a passenger car or truck with a registered gross weight of not more than 14,000 pounds. This registration plate requires a \$26 fee, provided the vehicle has current registration.

NOTE: This form requires a fee. Please review the instructions below carefully prior to submitting the application. For a complete listing of motor vehicle fees, refer to [Form MV-70S, "Bureau of Motor Vehicles Schedule of Fees,"](#) found on our website at www.dmv.pa.gov or scan the QR code found at the top of this application.

NOTE: If your vehicle does not have current registration and you are applying for registration **in addition** to the military registration plate, complete and attach your vehicle renewal application or [Form MV-140, "Request for Registration,"](#) and attach a check or money order made payable to the Commonwealth of Pennsylvania for the appropriate registration renewal fee in addition to the appropriate registration plate fee.

ELIGIBILITY REQUIREMENTS

A Pearl Harbor Survivor registration plate applicant must submit a legible photocopy of one of the following, which indicates the applicant was present at Pearl Harbor on Dec. 7, 1941:

- * A copy of the verification made by the U.S. service unit from the appropriate branch of the Armed Forces in which the applicant served.
- * For non-military applicants, documentation from the U.S. Civil Service Commission such as an ID card or other written verification.

Members of a Pearl Harbor Survivors Organization may have the organization verify an applicant's qualification in Section D in lieu of a copy of documents above.

NOTE: Pearl Harbor Survivor registration plate is not yet available for personalization.

- To replace a lost, stolen or defaced registration plate that is damaged, but not beyond recognition, complete and submit [MV-44, "Application for Duplicate Registration Card or Replacement of Lost, Stolen or Defaced Registration Plate."](#) along with a photograph or tracing of the registration plate for identification purposes. A registration plate is considered to be defaced when the registration plate is damaged by a specific incident such as a traffic accident, cutting, scraping or damaged caused by intense cleaning or harmful chemicals. There is a fee of \$13 to replace a lost, stolen or defaced standard issue or specialty registration plate. If your registration plate is a personalized registration plate, it will be replaced with the same configuration as before at no cost. Personalized registration plates that are lost or stolen are not able to be replaced with the same configuration. If your personalized registration plate was lost or stolen, we will replace it with the same style of registration plate, however, customers will be required to select a new configuration. The registration plate will be produced with the new configuration if it is available. Please make sure to indicate that you are replacing a personalized registration plate on the front of the [MV-44](#). If an immediate replacement registration plate is needed while waiting for your replacement personalized registration plate, please complete and submit a second [Form MV-44](#), and the replacement registration plate fee. A standard issue registration plate will be issued until the replacement personalized, lost or stolen registration plate can be provided. **NOTE:** The replacement personalized registration plate will take approximately 6-8 weeks to receive in the mail from the time PennDOT receives and processes the application. **NOTE:** The replacement standard issue registration plate will take 7-10 business days to receive in the mail from the time PennDOT receives and processes the application.
- To apply for a **free registration plate**, due to current plate being illegible, the vehicle owner should visit our website at www.dmv.pa.gov and take [Form MV-46, "Application to Replace an Illegible Registration Plate."](#) to any official Pennsylvania inspection station for verification that their registration plate is illegible OR have a law enforcement official verify the need for a replacement registration plate on [Form MV-46](#). The vehicle owner is then responsible for signing and returning the completed [Form MV-46](#) to PennDOT in order to receive a replacement registration plate free of charge. Your registration plate will be replaced with the next registration plate in the series and with the same style of registration plate you are replacing. If your registration plate is currently personalized, PennDOT will replace it with the same style and configuration as the registration plate you are replacing. If replacing your personalized registration plate, please attach a photograph or tracing of the registration plate for identification purposes. **If an immediate replacement registration plate is needed while waiting for your illegible personalized registration plate, please complete and submit Form MV-44, "Application for Duplicate Registration Card or Replacement of Lost, Stolen or Defaced Registration Plate," and the replacement registration plate fee. A standard issue registration plate will be issued until the replacement personalized registration plate can be provided. NOTE:** The replacement registration plate will take approximately 6-8 weeks to receive in the mail from the time PennDOT receives and processes the application. **NOTE:** The replacement registration plate will take approximately 7-10 business days to receive in the mail from the time PennDOT receives and processes the application. Please allow 8-10 weeks for delivery of personalized plates.
- To apply for a never received product, the vehicle owner should visit our website at www.dmv.pa.gov and complete [Form MV-50, "Application for Replacement of a Never Received Product."](#) By law, customers are entitled to a free reissuance of a product they never received if an application for a never received product is submitted within 90 days of the original issuance date. If a customer submits the application outside of the 90 days, the customer must submit \$7 for each never received registration card requested and \$13 for each never received registration plate requested, along with the application.
