


### Where we differ from the rest

- Doing Outreach in Legislative Offices Statewide continues to be the primary focus of Our Outreach program
  - Why Because the results prove it works
  - We intend to be as transparent as possible
  - Other types of Outreach include VA Facilities, Vet Centers, American Legion Posts, Senior Centers, etc.
  - And Yes we still do House calls when a veteran can not come to us



### Where we differ from the rest

- All of our DSO's are required to do Outreach
- Equipped to work anywhere with the latest technology
- All of our Accredited DSO's have remote access to the VA Database from anywhere in the state
- All have access to on-site IT support from any location
- All of our DSO's are required to complete Annual Training Certification including passing a VA Approved Examination



### Rules of the Road

- We continue to be fully committed to the FDC process and filling electronically
- We are ready to accept the responsibilities of the new Decision Ready Claim process the VA has just announced
- We are committed to having Paperless Records in almost every office.
- We are in our second full year of using "VetraSpec" which is a secure, online claims management system to maintain our records & reports
- All of our DSO's have or are working toward having, SEP/VBMS Remote access (2 currently awaiting Accrediation)
- With the upgrades in equipment made in the past several years, we are able to file FDC's from anywhere that we have internet access


